- C. There will be no profit motive, whatsoever and all its activities would be prompted solely by service motive.
- D. The benefit is intended for the public at large without any discrimination of any caste, religion, creed, colour, sex etc.,
- E. The trust will not embark on any business activity.
- F. There should not be any benefit directly or indirectly to the founder, trustees, committee member or any concern in which any of these persons are interested.

1. Name of the Trust:

The trust shall be known as "**GOOD SHEPHERD CHARITABLE AND EDUCATIONAL TRUST**"

2. REGISTERED OFFICE: (Rental Building)

3. OBJECT CLAUSE:

1. To start, run, takeover, establish educational institutions like-Primary, Middle, Higher Secondary Schools, Matriculation Schools, CBSE Schools, Arts, Science, Polytechnic, Medical, Engineering Colleges, Universities and other educational institutions, Scientific, Computer Center, Industrial and Technical and do all the things that are necessary for establishment, management and promotion of such educational Institutions. The trust may also take up the managements of such Institutions established by any similar Trust or any other enactments in force or that may be brought into force by the State or Central Government.
2. To establish distance learning Study Centres by entering into MOU with universities and to provide information and other support services, offer courses authorized by the universities, to the registered students and to make arrangement for Personal contact programmes, practical classes, laboratories and such other facilities as demanded by the courses allotted and to make necessary arrangements for the training of the students and help the students in getting suitable jobs.
3. To Act as Education Consultants with a view to provide quality services in the field of education to students in India and abroad and to act as education consultancy cum student counseling center which offers consultancy services for obtaining higher studies all over India and abroad and to act as authorized representative of reputed universities and colleges in India and abroad with a purpose to identify, promote and maintain quality education program which shall contribute towards shaping individuals, to provide quality service to enable students and faculty to achieve the highest levels of perfection possible, provide a platform for intermingling of universities, people, countries, organizations and co-operates for exchange of ideas, views and research and to provide universities with the tools to give their best services through understanding cultural mindsets and demographic and analytical tools to spread their message into the heart of the student population.

4. To foster modern education coupled with latest information Technology techniques, which will boost the confidence of the younger generation and will provide the necessary competitive edge in today's world with effective learning & teaching process.
5. To provide counseling facilities to the youth to select appropriate career path so that they can leverage maximum benefit out of their education.
6. To assist the unemployed youth in finding jobs or becoming self-employed through the establishment of Employment Bureaus and other facilities needed and to create awareness on career options and to provide the opportunities under Government schemes and to work for the youth development activities.
7. To take efforts in eradicating illiteracy.
8. To give financial aids by grants to deserving students studying in the above institutions and to conduct workshops for all ages to promote education.
9. To align, associate, network with any university or educational Institutions for the objects mentioned above.
10. To construct, establish, maintain, run, develop, improve hospitals, clinics, dispensaries, maternity homes, rescue homes, to help treat all people without any distinction of caste, religion, creed, color, or community at costs affordable to them, or even free of cost;
11. To provide health care to the poor, distressed, afflicted, and the physically, mentally or socially handicapped persons which shall include maternal and child care, environmental sanitation, control of communicable diseases, geriatric care etc.,
12. To carry out objects of general public utility and security, such as village upliftment, rural reconstruction, public health and hygiene, community development, welfare of women and children, promotion of cottage industries, self-employment schemes etc; and to start, establish, conduct, take over, maintain and manage and help any institution considered necessary to secure these objects like orphanages, old age homes etc.

13. To uplift the rural public in the matter of literacy, self-employment, awareness of health, child care, women welfare, family welfare and birth control programs, control and eradication of drug addiction etc.
14. To enable; youth to acquire skills for employment and self employment.
15. To give food, clothing, medicines, cash grants, and any other help that may be necessary to the poor and afflicted people in distress, affected by natural calamities such as earthquake, floods, famines, etc.,
16. To grant donations for the support of orphanages and welfare institutions and to provide loans to poor for marriage and social obligation.
17. To establish institutions for providing technical skills to the people for enabling and encouraging them to take up self employment.
18. To undertake the promotion of literacy among the workers and their children To arrange seminars and camps to bring out the awareness among people regarding matters affecting their health hazards of their working conditions and other things.
19. To support the Government development programs without interfering in any political action and without joining any political party.
20. To promote conservation of environment and ecology.
21. To get finance, subsidy through the Government and utilize it for the upliftment of the rural people.
22. To try to reach the rural people health education and protect them from the diseases.
23. To support the farmers by introducing the modern methods of their cultivation and benefits and to spread appropriate technology among the people in agriculture, dairy farming, poultry farming, fishing and like industries.
24. To provide a home for destitute women and give them training in small scale industries.

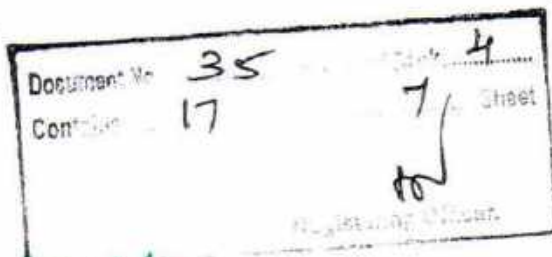
25. To help the orphans by forming orphanage to provide them with food, shelter, dress and education.
26. To conduct medical camp to help the rural people.
27. To help the rural people in family planning by explaining the merits of small family and demerits of large family.
28. To insist the rural women about the importance of education.
29. To develop a library where sociological research in the above said areas can be undertaken.
30. To establish, run and maintain orphanages, children homes for the aged widows and destitute.
31. To provide vocational training to the destitute, especially widows.
32. To involve in drug rehabilitation and alcohol de-addiction and AIDS prevention and care.
33. To work in co-ordination with any other Trust or institution having similar aims and objectives, aid, assist other agencies, or to undertake any activity entrusted or delegated to it by effectively carrying out such activities, in whole or in part, as per the capabilities.
34. Moneys disbursed for the purpose of other charitable activities in pursuance of the above objects will be confined to Indian shores.

4. SOURCES FOR THE TRUST

The founder hereby sets apart a corpus for the object of the trust which will be reserved for the sustenance of the trust.

The Trust may receive donation, gifts, voluntary contribution, grant in aid, assistance from the donors either towards corpus or for the revenue

expenditure for charitable or educational purposes as contemplated in the object clause from all i.e. Individual, Government, Institutional donors either in India or abroad for the furtherance of the objects as specified in the object clause.

5. APPLICATION OF INCOME:

- a) The income and funds of the trust will solely be utilized towards the objects & no portion of it will be utilized for payment to the founder, trustees, members of the committee, office bearers by way of profits dividends, interest, bonus etc., or otherwise.
- b) Corpus Fund or Capital Fund or Earmarked fund shall be invested in such manner as prescribed under section 11(5) of the income Tax Act 1961 till the fund is defrayed for capital or revenue expenditure for the maintenance and sustenance of the objects for which the fund is created.
- c) Where the income of the relevant year is not applied for charitable or educational purposes the trust may accumulate or set apart either the whole or part of its income for future application for the purposes of the trust by complying the provisions of the Income Tax Act, 1961.

6. MANAGEMENT

The management of the affairs of the trust shall vest in a board of trustees. The board shall have all the powers incidental to and necessary for carrying out the administration and management of the trust having regard to the objects and purpose thereof. In the absence of consensus the board shall function in accordance with the decision of the majority of the members of the board.

- a) Mrs.Selvi.V Shall be the Managing Trustee for life and shall be in over all control of the day to day affairs of the Trust.
- b) The Board shall not sell or alienate the properties of the Trust. However In furtherance of the Objects, The Board may sell the property with the consent of majority of trustees. All these powers shall be well within the ambit of the objects of the trust hereby created.

- c. Any trustee can be removed from Trusteeship for insolvency or misconduct by a resolution passed by majority of the trustees after giving an opportunity to him in writing.
- d. Any trustee desirous of retiring from the trusteeship shall be entitled to do so after giving one clear calendar month's notice in writing to the remaining trustees.
- e. All the trustees shall hold office for their life time except in the case of trustees who want to retire voluntarily or who are removed from trusteeship.
- f. In case of any vacancy in the Board of Trustees arising on account of death retirement, resignation or otherwise of any trustees, the surviving or remaining trustee or trustees as the case may be shall have full powers to constitute and represent the Board of Trustees for the time being.
- g. The trustees shall, in the case of vacancy have the power to co-opt a Trustee or trustees as the case may be, fill up the vacancy or vacancies as the case may be within a period of thirty days from the date on which the vacancy arises by way of nomination.
- h. In the event of any vacancy arising in the office of the Managing Trustee by resignation, death or otherwise, the remaining trustees shall at first co-opt a trustee to fill up the vacancy in the Board within thirty days from the date on which the vacancy arise and shall elect the Managing Trustee from among themselves.

7. POWER OF THE BOARD OF TRUSTEES

The Managing trustee shall be the chief executive of the trust and shall have the general power to conduct the affairs and management of the foundation. For this purpose, the managing trustee shall cause proper accounts to be maintained of the receipts and payment, the income and expenditure and assets and liabilities of the trust. She shall duly carry out all the decision made by the

Board of Trustees. The managing trustee shall exercise such powers as may be designated to her by the Board of trustees.

The trustees shall have absolute power and authority to administer the trust, its institutions, properties and funds and to do all acts, deeds and things as are calculated to promote the objects for which the trust is established. The Board of Trustees has the Power:

1. To receive donation.
2. To apply the income
3. To accumulate the income and corpus.
4. To appoint, suspend or remove staff, allot their duties, fix their salary.
5. To sue, defend suits and compromise.
6. To invest, reinvest or change the nature of trust funds.
7. To borrow funds.
8. To sign, authorize, execute any documents, agreement, covenants etc.,
9. To form any committee.

8. DUTIES OF THE BOARD OF TRUSTEES:

The Board of Trustees has the duty:

1. To conduct meeting once in 3 months and to frame rules and regulations for the conduction of meeting. At least one week's notice in writing shall be given for every meeting for the board of trustees provided however the managing trustee shall have power to convene a meeting at shorter notice for transacting any business considered by him to be urgent.
2. The quorum required for a meeting of the board of trustees shall be two.
3. To represent before the Government, Government bodies, financial Institutions, funding agency etc.,
4. To preserve documents, accounts, title deeds, vouchers etc.,
5. To keep proper minutes of the proceedings of the Board and resolutions carried in the meetings.

9. BANK ACCOUNT:

Bank account can be opened in the name of the trust in any of the Nationalized, Scheduled, Co-operative, Regional Rural Banks, MNC or other banks of Financial Institutions as the Board of Trustees decide from time to time. The Said account shall be operated by the MANAGING TRUSTEE only for and on Behalf of the trust. The managing trustee is empowered to execute any Documents for opening operating or raising loans for the objects of trust from any of the said banks.

10. ACCOUNTING YEAR, ACCOUNT AND AUDIT

The accounts of the trust shall be regularly maintained every year and the accounts shall be closed by 31st March and the same shall be audited by a qualified chartered accountant.

11. INVESTMENT:

The investment of the funds of the trust shall be in accordance with provisions of section 11(5) read with section 13(1)(d) of the Income Tax Act, 1961.

12. BENEFICIARIES:

The benefits of the trust are open to all, irrespective of Caste, Religion, Sex, etc.,

13) REMUNERATION:

The income and funds of the trust will solely be utilized towards the objects and no portion of it will be utilized for payment to the founder, trustees, committee members by way of profit, dividend, interest etc.

14) AMENDMENT

The Board by passing a resolution in the Board meeting authorizes Managing Trustee to amend the Trust Deed subject to the following covenants:

1. The amendment of the trust will be carried out only with the prior approval of the Commissioner of Income Tax Exemptions, Chennai.

2. The amendment would not extend to alter the basic character or objects of the trust and further no such amendments which may prove to be repugnant of sections 2(15), 11, and 13 and 80G of the Income Tax Act shall be made.

15. DURATION OF TRUST

The trust hereby formed shall be irrevocable.

16. ACTIVITIES

The objects, activities of the trust shall be carried out only in India without any profit motive.

17. DISSOLUTION OR WINDING UP


In the event of dissolution or winding up of the trust, the assets remaining as on the date of dissolution shall not under the circumstances be distributed among the founder, trustees, committee members but the same shall be transferred to another trust whose objects are similar to those of this trust and which enjoys recognition under section 80G of the Income Tax Act. i.e. the assets/liabilities will be transferred to a trust not only having similar objects but also enjoying exemption u/s 80G of the I.T. Act at time of transfer.


18. OTHERS.

The trust shall under no circumstances do or venture into any business directly or indirectly and as such the question of maintenance of separate books of account, compliance of the provisions of section 11{4} and provisions to section 80G{5} {i} of the Income Tax Act, 1961 does not arise.



